1.0 Unless granted leave of absence by the KMHA Board of Directors, or for reasons of health, any member of a KMHA Board who misses more than two (2) consecutive meetings or three (3) in total may have their position declared vacant by a majority vote of the board.

2.0 To ensure continuity of KMHA programs the election of the board will be staggered in appointment date and the appointment term of some positions extended

- President 2 Year Term Position will be up for election on odd years.
- VP Hockey Programs 2 Year Term Position will be up for election on even years.
- VP Hockey Operations 2 Year Term Position will be up for election on odd years.
- Treasurer 2 Year Term Position will be up for election on even years.
- VP of Communications, Director at large (2) will be one year positions.

3.0 To minimize conflict of interest and ensure the programs and initiatives set out by the board are executed, members of the KMHA Board of Directors and the Rep Coach Co Coordinator are not allowed to coach a KMHA competitive hockey team.
